**MARINE DECK OFFICERS LICENSURE EXAMINATION
RESULTS RELEASED IN ONE (1) WORKING DAY**

The Professional Regulation Commission (PRC) announces the passing in the **July 23, 2005** Practical Examinations of **7** out of **8** examinees who previously passed the theoretical examination given in various dates/ranks for the **Marine Deck Officers Licensure Examinations** by the **Board for Marine Deck Officers** in **Manila** and a total of **7** examinees in the July 2002 Practical Phase .

The members of the Board for Marine Deck Officers who gave the licensure examinations are **Capt. Ernesto C. Bondoc**, Chairman; **Capt. Constantino L. Arcellana Jr.**, **Capt. Jaime C. Aquino**, and **Capt. Abelardo M. Pacheco**, Members.

The results were released after one (1) working day from the last day of examinations.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start today Tuesday, July 26, 2005. Those who will register are required to bring the following: latest Community Tax Certificate; 3 pieces passport size picture (colored with white background) with appropriate shoulder boards, and 1 piece 1" x 1" picture, metered documentary stamps worth P45, and 1 long clear envelope; and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P750 for 2005-2010. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The oath-taking ceremony of the successful examinees in the said examination as well as the previous ones who have not taken their Oath of Professional will be held before the Board on Tuesday, August 2, 2005 at 1:00 o'clock in the afternoon at the Fiesta Pavilion, Manila Hotel, One Rizal Park, Roxas Boulevard, Manila.

Registration for membership with the **Masters and Mates Association of the Philippines (MMAP)** will start today, July 26, 2005.
