**OPTOMETRIST LICENSURE EXAMINATION
RESULTS RELEASED IN ONE (1) WORKING DAY**

The Professional Regulation Commission (PRC) announces that **74** out of **103** passed the Optometrist Licensure Examination given by the **Board of Optometry in Manila** this **July 2005**. The result of examination with respect to one (1) examinee was withheld pending final determination of his liabilities under the rules and regulations governing licensure examinations.

The members of the Board of Optometry are **Dr. Mariano M. Tanada, Jr.**, Chairman; **Dra. Rosalinda B. Bono**, **Dra. Teresita H. Marcaida**, **Dra. Divinia Lourdes R. Reyes** and **Dra. Anita S. Villarta**, Members.

The results were released in one (1) working day from the last day of examination.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start on Monday, July 25, 2005 but not later than August 12, 2005. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete nametag), 1 piece 1" x 1" picture (colored with white background and complete nametag), 2 sets of metered documentary stamps, and 1 short brown envelope with name and profession; and to pay the Initial Registration Fee of P600 and Annual Registration Fee of P450 for 2005-2008. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The oathtaking ceremony of the successful examinees in the said examination as well as the previous ones who have not taken their Oath of Professional will be held before the Board on Thursday, August 18, 2005, 1:00 o' clock p.m., at the Mabuhay Palace, Manila Hotel, One Rizal Park, Manila.

Membership registration with the **Integrated Philippine Association of Optometrists, Inc. (IPAO)** will start on Monday, July 25, 2005.

Those who passed and have not taken their oath in the Special Certification in Ocular Pharmacology given in February 2005 are hereby requested to attend the oathtaking ceremonies.
